# From Our Chairman: Congratulations 2024 Graduates

Greetings Tribal Citizens!!! I write today to raise my hands to all our 2024 Tribal Graduates! I and our Tribal Council have always been proud of the educational achievements of the young and older students.

I want to express deep appreciation for our Higher Education Committee led by Chair Beth Anders and including Theresa Lehman, Ann Tjemsland, Rochelle Blankenship and Vickie Carrol. They always honor not just the graduates every summer at our Annual Picnic but provide monetary awards to those who have excelled in school with exemplary academic grades. It is a small way our Tribe can say 'well done!' and encourage them on to the next chapter in either their educational goals or vocational aspirations.

We have noted in the past that this program has been targeted at the undergraduate programs, but several years ago at the urging of Kurt Grinnell, we expanded this assistance to post-graduate students. These numbers have continued to increase in recent years. I am very encouraged by this success, and we definitely want to provide support for these students to be prosperous in their academic pursuits.

Like many things, education is becoming more expensive. The Tribal Council, at the recommendation of the Higher Education Committee, shifted the policies to encourage the students to be responsible for a portion of their basic living related expenses. This has directly resulted in an increase in Tribal students' graduation rates. The Tribe still covers the costs of the education, e.g. tuition, books, fees, etc. I believe this new policy is working. I want to thank Gage Jackson, our Professional Development Coordinator, who is always there to assist the students in pursuing additional scholarships that help them cover some of the financial cost of education.

Loni Greninger and I have been very active with the Universities and Colleges to urge and encourage them to have strong supportive programs to assist students in their transition from high school to higher institutions, which are definitely different environments and much more competitive. Some like the University of Washington, Evergreen College, and our local Peninsula College have Student Longhouses where the students can gather and enjoy cultural and traditional practices as well host events to share cross-cultural knowledge.

Many of us Tribal leaders encourage these institutions to establish American Indian Studies programs offering classes that provide a strong background on what Nation-Building and leading a Tribe is about, including leadership and administrative knowledge and skills. I remember when I graduated in 1982 and began my journey with our Tribe and the political and economic programs had absolutely no reference to Indian Tribes. I had to learn how to lead and build our Tribe's governmental foundation by 'the seat of my pants'. I had to seek out Northwest leaders, like Joe DeLaCruz (Quinault) and Mel Tonasket (Colville), to find out how to engage the Bureau of Indian Affairs (BIA) within the Department of Interior or how Indian Health Services (IHS) works and what they could do to help our Tribe. There were many others, such as Housing and Urban Department (HUD) or the Economic Development Administration (EDA) within the Department of Commerce. It was a very steep learning curve. Students today have a much better opportunity with higher education institutions with specific programs educating them on how the political and administrative federal and state systems work.

To lead a Tribe, and our various programs, is much more complicated than years ago. As we continue our journey of becoming Self-Governing and Self-Reliant, I urge and encourage to always remember who we are as Indigenous people, our culture, our traditions and work of the warrior of the past. I'm delighted that our new Tribal Library and exhibit hall provides our people and community a glimpse into that history.

As we look at potential leaders, they must understand what Nation-Building is about and these American Indian Studies courses help them understand the mission of all Tribes because all Tribes seek to restore governmental capacity to protect sovereignty, jurisdiction, and treaty rights, while building essential programs and services for Tribal Citizens.

We are honored to congratulate our graduates, raise our hands to you and now look to you as the upcoming generation who will become the next Tribal warriors for our Tribe, our Jamestown Tribal community, and possibly Indian Country.

# What is Tribal Self Governance?

As I approach Fall of 2024, I'm reminded that it will be my halfway mark as a Tribal Council Member.

Through-out this time, I've had many learning experiences that have taught me more about our Tribe, as well as how other tribes across the United States function and operate-according to their needs and culture. And, why it's important to educate myself on what tribes do to maintain and reach goals within their individual nations. Although I had basic knowledge of what Tribal Self Governance was, my eyes were opened to a whole new understanding of its value when I attended the 2024 Self Governance Conference in Arizona for 5 days.

A significant contribution to the success of tribes, including Jamestown, is the ability to attain Tribal Self Governance status. Out of the 574 tribes within the United States, 52% applied for and received this status. Jamestown became a self-governance tribe in 1994. We were one of seven tribes in the nation to participate in a self-governance demonstration project-which allowed many programs and services administered by the Bureau of Indian Affairs to be transferred to the tribe. This essentially changed how our Tribe was able to operate and make decisions based on our needs.


So, what exactly is Tribal Self Governance? It's a framework that empowers tribes to prioritize their needs, plan their futures and manage their own affairs. It allows tribes to form their own governments, make and enforce laws, tax, regulate activities and determine membership within their jurisdiction. Tribes are able to have control over Indian Health Service (IHS) program funds in order to better serve their communities. They become able to determine where and how to spend the money that is in the best interest of their own people.

The process involves negotiating a compact (government to government agreement) with the federal government, which outlines the responsibilities and funding for specific programs. Once approved, tribes can assume control over those programs, such as healthcare services, education, and social services, to better meet the needs of their individual communities.

Having become a Self-Governance Tribe 30 years ago has enabled us to make decisions that have helped us manage change within our community. When I attended this conference, I listened intently to the conference speakers, and panels that brought forth information and education on the topic. One of these speakers was our Chairman/CEO, Ron Allen. He is known across the nation as a leader in Self-Governance and is highly admired and respected by other Tribes and political figures. Others (Tribes) seek out his advice as to how they can become more self-reliant and self sufficient regarding their tribal sovereignty. In other words, how can they (tribes) exercise their rights by managing their own resources effectively and efficiently as an independent nation-without the previous heavy burden of reporting unnecessarily to the federal government. Jamestown S'Klallam Tribe, through strong community participation, strong leadership, a great staff & strategic planning is on a good path of Self Governance, while practicing true sovereignty. Its success is visible and speaks for itself. It was years in the making, beginning with our ancestors who didn't give up on fighting to maintain to stay intact as a tribal community-in spite of resistance and adversity. It took strong leaders, even then, to recognize the need to persevere in fighting to be recognized and operate as a people. In 2024, we continue to fight that battle to uphold our rights and our treaties-in order to remain Jamestown strong!

### **Gather from the Sea Weekend**

Day 1 – Salt Creek (between qwa?šénem "Crescent Bay" and tkwáyŋexw "Freshwater Bay"): Tide Pool Foods. A group went out to harvest gooseneck barnacles, limpets, chiton, and mussels. Salt Creek is a special area to harvest for S'Klallams/Klallams because there was a time we did not have access to harvest in the area. Through the work of our elders and Natural Resources Department, that access has been restored!

Day 2 – tkwáyŋxw "Freshwater Bay": Seaweed. Not only did we harvest seaweed, but also heard the story of Kelp Woman. Over these last few years, the Traditional Foods Program has been including kelp and seaweed in everyday recipes to show how easy it is to incorporate these foods into our diets. Pictured here is a rice, onion, and seaweed dish made by Lisa Barrell.

Day 3 – stətíləm cáwŋən "Jamestown Beach". The last harvest day focused on clams at our tribal beach property and a feast! Bringing all the harvested foods together (and some good frybread), dishes were prepared and enjoyed together at Jamestown Beach!

# Tribe Purchases Two All Electric Vehicles

Recently, the Jamestown S'Klallam Tribe has acquired, not just one, but two electric vehicles. These are the first all–electric vehicles the Tribe has purchased.

The Ford E-Transit van has been customized and includes handicap accessible features, like an electric ramp for wheelchairs. It has the capacity to seat up to six individuals. This vehicle is for the Healing Clinic and can offer transportation assistance for patients. The Natural Resources Department has purchased a Ford Lightening truck to support the staff with field work.

As part of the Tribe's Carbon Neutral Plan, the Tribe will continue to incorporate more electric cars and trucks.



#### Dear Legal Aid Abby,

I'm currently pursuing a protection order in state court. The judge has asked that both of us appear in person, if possible, but I'm too scared to even be in the court room with my abuser. Is there anything I can do without risking the case?

-Scared & Alone

#### Dear Scared & Alone,

First off, I'm sorry that you are experiencing harm in your relationship, but I'm also proud that you're taking the steps needed to get the protections you need to feel safe. While this process can feel overwhelming, you have resources and rights to make things easier. If you haven't already, please consider reaching out to a local domestic violence advocate for guidance and support. Advocates are professionals with extensive knowledge of local resources, law practices, and court procedures in your area.

Under Washington State law, you do not have to attend your protection order hearing in person. As of 2022, you, the other side and witnesses may attend protection order hearings remotely, preferably by video on platforms like Zoom/WebX or by telephone. If you request to attend a hearing remotely, the judge must grant your request.

Additionally, to help ensure your safety, the Court is obligated to help protect the privacy of your phone number, email address, and other contact information; including letting you have a virtual background on to help keep your location private. That said, you should also make sure that you don't openly discuss your contact information or whereabouts during the hearing. You can also check the court website, since there should be information posted to help you request a remote hearing. However, if you still have questions, you should reach out to the local Court Administrator; they handle setting up and managing remote appearances and know each county's processes.

Hopefully, knowing that these options are available to you can help put your mind at ease. Protection orders are available so that you can feel safe, and remote appearances are available to help you feel safe before the final order is signed.

If you have any other questions regarding the civil protection order process, Northwest Justice project provides several useful tools through WashingtonLawHelp.org. There is a "Personal Safety" section that contains several how-to guides as well as an online tool to help you complete your domestic violence petition.
